Lyle Coe has extensive experience as a Project and Construction Manager. Although many of his current clients include 10,000SF \$25MM plus custom single-family residences, many are much larger projects where he has been hired to manage and trouble shoot multi-million-dollar issues, or act as an expert witness and provides cost estimates on General Construction, Mechanical, Electrical, Plumbing and Fire Sprinklers (MEPF) issues for buildings up 1,200,000 sf. or more in size.

His experience includes government and private sector work on both interior and exterior design problems and issues, which may include roofing, flashing, framing, MEPF issues and/or general contractor or subcontractor standard of care. He has hired and supervised engineering and design teams for projects with over \$3MM in just design services alone. He has been a consultant as a Construction Management Advisor (CMA) in planning, scheduling, budget cost estimating, negotiations, and contracting methods for general contracting to specialty sub-contracts. Past clients included national architectural and engineering firms, the University of California at LLNL as well as corporations such as AT&T, Pacific Bell, and IBM. and transportation facilities like BART, Port of Oakland and SFO Airport.

Other specialties that Mr. Coe is sought out for include contract reviews and claims analysis, construction cost estimating, change order negotiations, expert witness testimony and destructive testing oversight.
